FIRSTDOWN

Purchasing a home can be expensive. Let the **FIRSTDOWN** program help.

Many homebuyers find it difficult to pay for the down payment and closing costs associated with buying a home. Three organizations -- First National Bank, the Federal Home Loan Bank and the Nebraska Housing Developers Association—have partnered to form the FirstDown program which provides \$6,000 grants to qualifying home buyers to assist with their down payment and/or closing costs. *

How to Qualify for the FIRSTDOWN Program

In order to qualify for a FirstDown grant, a buyer must meet the following eligibility criteria:

- The home must be located in Nebraska
- Household incomes must be at or below 80% of the area median income
- Additional requirements may need to be satisfied as determined by the Nebraska Housing Developers Association
